

**WIRE WELD, INC.  
LIMITED WARRANTY**

For a period of one (1) year from the date of shipment, Wire Weld, Inc. ("Wire Weld") warrants that its products shall be free from defects in materials and workmanship. This warranty is limited to the original purchaser of the products.

This warranty shall not apply to problems arising from normal wear and tear; failure to follow Wire Weld's instructions as to installation, use and/or maintenance and/or other improper installation, use and/or maintenance; willful misconduct; negligence; use of products with other products not manufactured or approved in writing by Wire Weld; accident or other circumstances beyond Wire Weld's control; products modified (including, but not limited to modifications through the use of parts or attachments not approved in writing by Wire Weld) or repaired by anyone other than Wire Weld or its authorized agents.

This warranty is limited to the products themselves and does not include labor or shipping charges incurred in replacement or repair of any such products, which are purchaser's responsibility.

For warranty service, please contact Wire Weld at \_\_\_\_\_ and indicate the nature of the possible defect.

If Wire Weld determines there may be a defect, Wire Weld will issue a return authorization number. The defective products must be returned at purchaser's expense for warranty inspection using the return authorization number as identification within ten (10) days of the return authorization date. DO NOT return products to Wire Weld's factory without Wire Weld's prior consent, as they, as well as C.O.D. shipments will be refused. If Wire Weld determines that there has been a breach of warranty, Wire Weld, at its sole option, shall either repair or replace the products and return such products to the purchaser. Such repaired or replaced products shall be warranted for the remainder of the one-year warranty, if any. Defective products returned to Wire Weld become the property of Wire Weld.

**PURCHASER'S SOLE AND EXCLUSIVE REMEDY, AND WIRE WELD'S SOLE OBLIGATION UNDER THIS WARRANTY, SHALL BE LIMITED TO SUCH REPAIR AND/OR REPLACEMENT.**

IN NO EVENT WILL WIRE WELD BE LIABLE FOR SPECIAL, INCIDENTAL, INDIRECT OR CONSEQUENTIAL DAMAGES, DAMAGES FROM LOSS OF USE, LOST PROFITS OR COST OF PROCUREMENT OF SUBSTITUTE PRODUCTS, EVEN IF WIRE WELD SHALL HAVE BEEN ADVISED IN ADVANCE OF THE POSSIBILITY OF SUCH LOSSES, COSTS OR DAMAGES, WHETHER IN AN ACTION BASED IN CONTRACT OR TORT, INCLUDING, WITHOUT LIMITATION, ANY ACTION FOR NEGLIGENCE. IN NO EVENT WILL WIRE WELD'S TOTAL LIABILITY FOR ANY DAMAGES OF ANY TYPE ON ACCOUNT OF ANY NON-CONFORMING PRODUCTS EXCEED THE AMOUNT PAID BY PURCHASER TO WIRE WELD FOR SUCH SPECIFIC PRODUCTS.**
